Financial Report by Bobby Hall

Financials as of December 31, 2023.

Kent Blackinton motioned to move \$150,000 from 22nd State Bank to First Horizon Bank to collect highest interest. Duncan Millar seconded. A unanimous vote of approval followed.

Kent Blackinton motioned to approve Financials. Aaron Watz seconded. A unanimous vote of approval followed.

- Digital Campaign Results
 - OTA Expedia campaign kickoff results
 - o Duncan Millar requested year over year results in next report.

- > Amadeus Proposal
 - New proposal targeted at business travelers in immediate surrounding areas, targets travel agents with a history of booking in those areas.

District Management Plan Changes

- Board of Directors discussed the difference in timelines for "minor" or "major" changes to the District Management Plan in order to renew
 - Minor changes would not require a petition from TID properties
 - Major changes would require a petition from TID properties
- ➤ All Board of Directors members present at meeting are in favor of adjusting the assessment amount in the new District management plan, whether that be an increase to \$2 or changing the assessment methodology to a percentage of room rate.

- ➤ All Board of Directors members present at meeting are in favor of adjusting section VI. "GOVERNANCE" subsection B. "Continuation of City Services" of the District Management Plan to increase Visit Mobile's baseline funding.
- ➤ Discussions will need to be had with the three Board of Directors members not present along with socializing the ideas with TID hotel owners and City Council members before writing the new District Management Plan.
